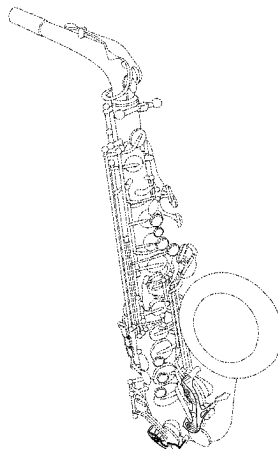
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the saxophone guards; FIG. 2 is a right side view of the saxophone guards; FIG. 3 is a left side view of the saxophone guards; FIG. 4 is a front view of the saxophone guards; FIG. 5 is a rear view of the saxophone guards; FIG. 6 is a top plan view of the saxophone guards; and, FIG. 7 is a bottom plan view of the saxophone guards. The portions of the saxophone in broken lines are shown for illustrative purposes only and form no part of the claimed design.

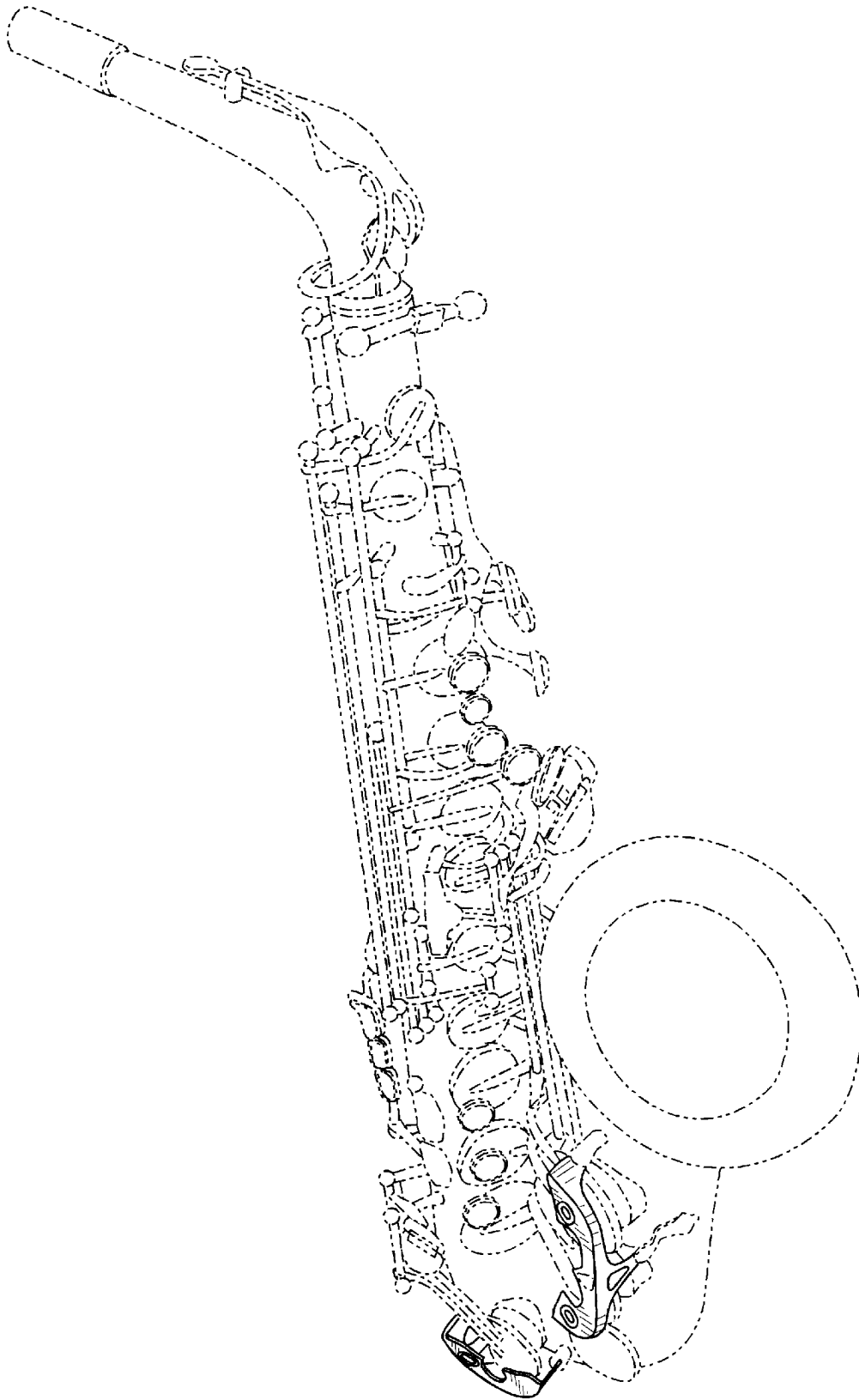

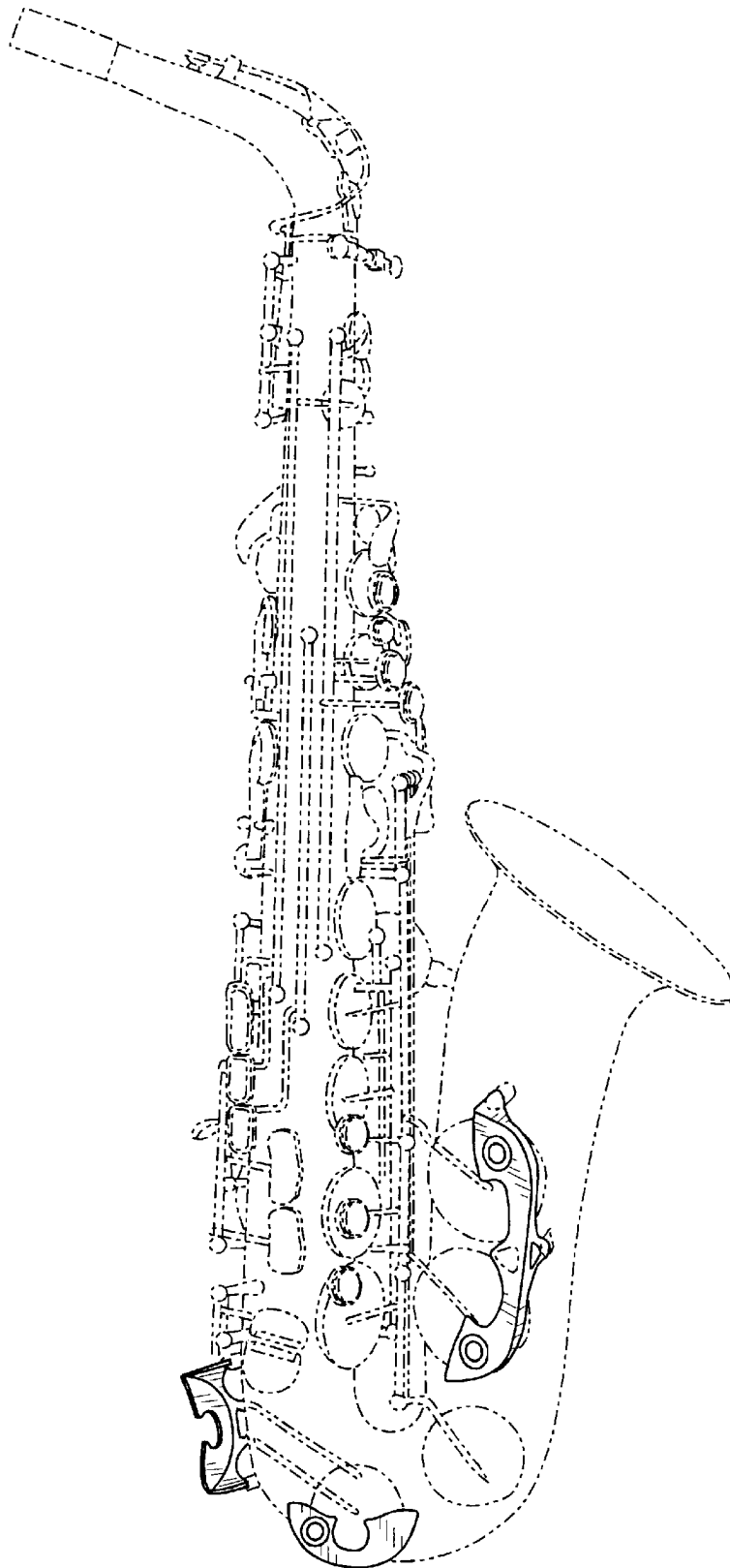

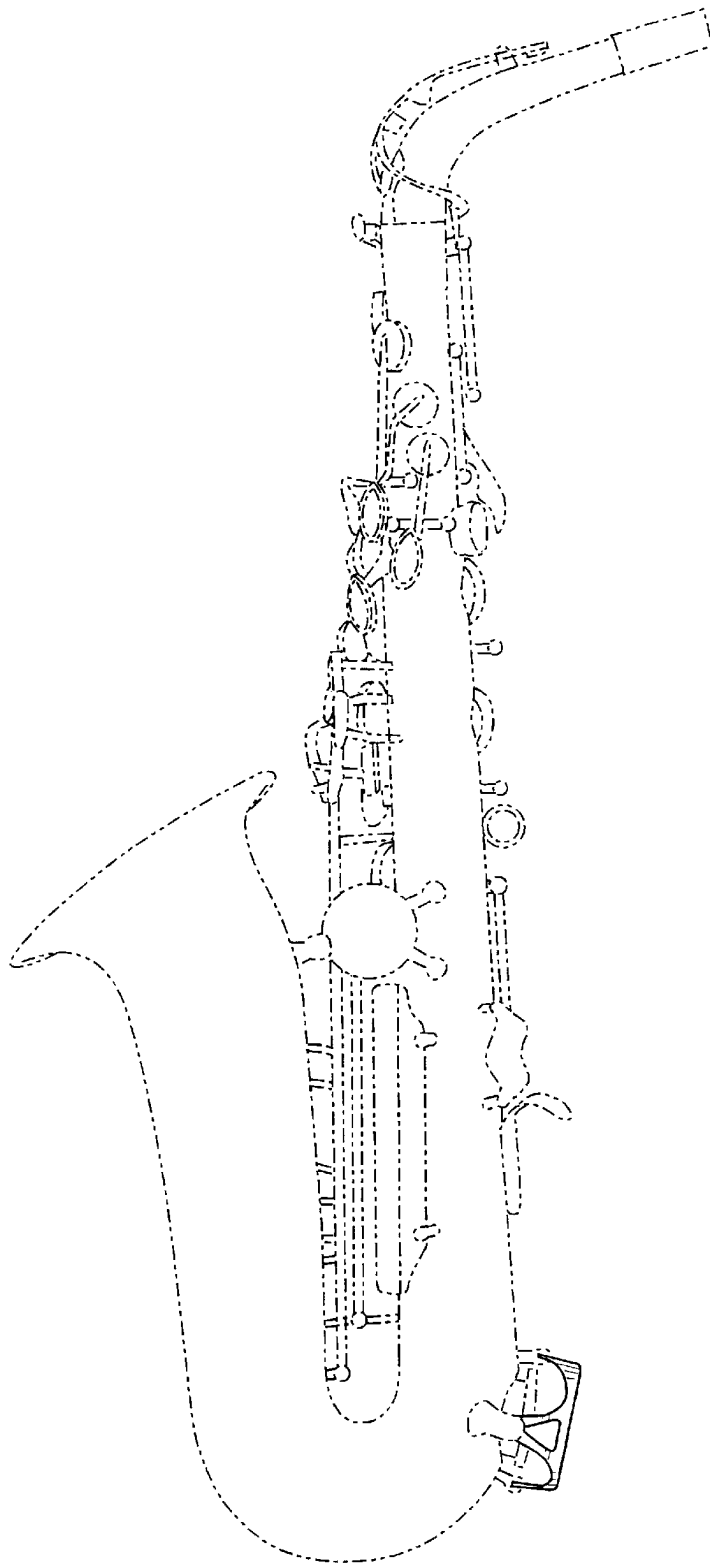

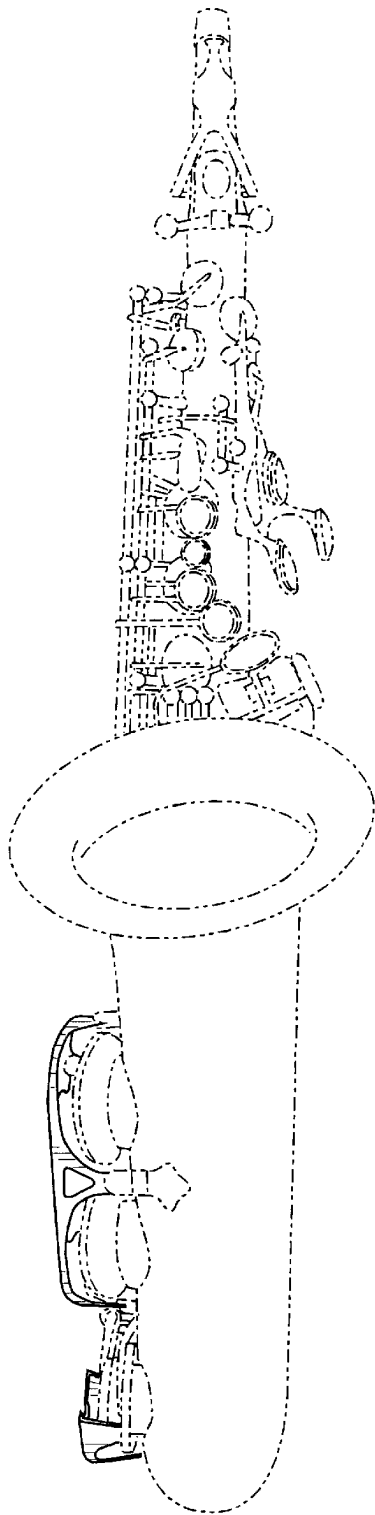

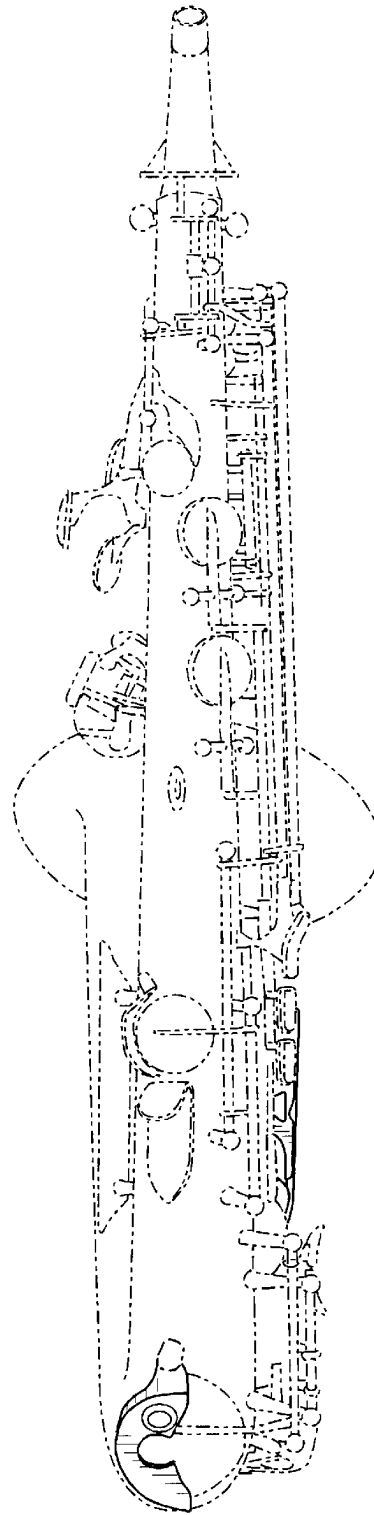

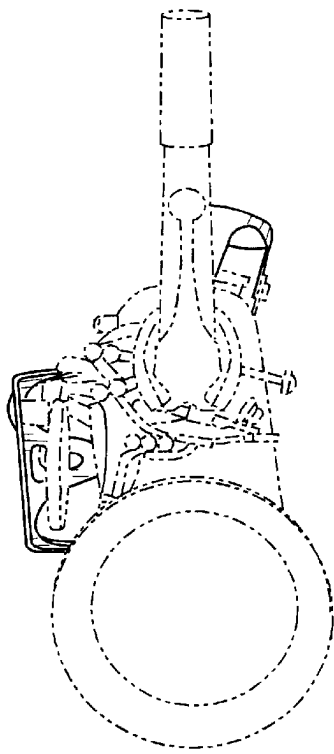

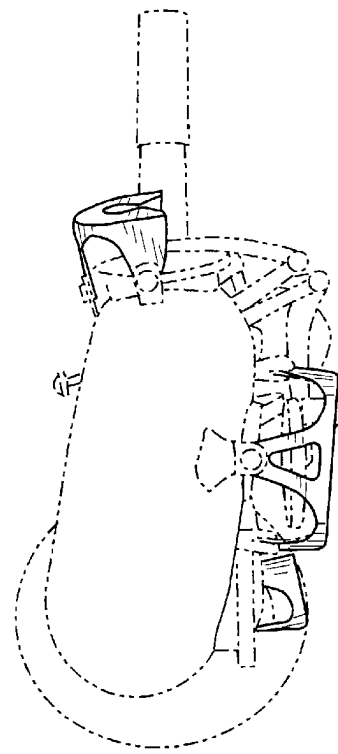
